These annoying forms are part of a potential situated project regarding the bureaucratic rituals within the educational institution I am currently part as a student. How the educational bureaucratic apparatus as an infrastructure can reflect policies about migration filter, border control and constitute a proof of the institution's transformation? The document can (de)construct, classify or fragment the person but what conflict would emerge when the intimate story comes upon this artifact? These are some floating questions that haunt this project and also my mind.

My identity as a privileged migrant coming from the European South to the North for studies did not allow me to understand entirely the precarity and the violence of being in the marginal state of existing and non existing in the eyes of state. I started perceiving bureaucracy as an omnipresent immaterial border, a ghost infrastructure that you always encounter but don't really see - an infrastructure that lays in between the gray zone of visibility and invisibility. How bureaucracy makes us stupid and vulnerable in front of it? We rarely question it but we always have to perform it efficiently in order to exist properly.

The personal story is a moment to disturb the form's continuity, reveal the hidden violence of the document and transform it into an poetic interface of discourse.
